- A citizen of the Republic of the Philippines;
- · A person of good moral character;
- Must have passed the psychiatric/psychological, drug and physical tests for the purpose of determining his/her physical and mental health;
- Must possess a baccalaureate degree from a recognized institution of learning;
- Must possess the appropriate 2nd Level Eligibility;
- Must not be less than twenty one (21) nor more than thirty (30) years of age at the time of the appointment;
- Must not have been dishonorably discharged of dismissal for cause from previous employment;
- Must not have been convicted by final judgment of an offense or crime involving moral turpitude;
- Must be at least one meter and fifty-seven centimeters (1.57 m.) or 5'2" in height for male, and one meter and fifty-two centimeters (1.52 m.) or 5'0" for female.
- Must weigh not more or less than five kilograms (5 kgs.) from the standard weight corresponding to his/her height, age and sex;
